CAPITAL RAISING SUCCESSFULLY COMPLETED

Speciality Metals International Limited (ASX:SEI) (Speciality Metals or the Company) is pleased to announce that it has raised \$4,500,000 (with oversubscriptions) via the placement of 125,000,000 fully paid ordinary shares at a price of 3.6 cents per share (last trade price 3.5 cents per share).

The placement was undertaken pursuant to its placement capacity under Listing Rule 7.1 (15% Rule).

Use of Funds

The funds raised from the placement will accelerate the further development of the existing Retreatment Plant and to improve the necessary infrastructure to support the X-Ray Ore Sorter installation.

It is anticipated that the X-ray Ore Sorter will have a significant impact on the ability to process the material from the 12 million tonne stockpile. The Company expects the X-Ray Ore Sorter will be able to improve its overall cost competitiveness by reducing the amount of non-mineralised rock to be processed through the plant and is expected to significantly increase the grade of the feed material being processed. The objective is to enable the Company to become one of the most cost competitive tungsten producers in the world.

In addition, funds will be allocated to advance development activities around the Open Pit and the underground resource (subject to relevant permitting), in particular commencing studies related to 2 high-grade ore zones beneath the Open Pit.

It is the Company's intention to thoroughly review the historical geological records and commence its own validation work from both an geological and engineering perspective.

Executive Chairman, Russell Krause commented, "In-spite of the significant uncertainty in the global capital/financial markets it is an extremely strong vote of confidence by investors to support the Mt Carbine Tungsten Project."
