Lanstead Sharing Agreement

In March 2016, the Company signed Subscription Agreements to raise, in aggregate, \$1,875,000 before expenses from Lanstead Capital L.P. ("Lanstead") by way of a subscription for 75,000,000 ordinary shares at a price of \$0.025 per share. The Company also entered into a Sharing Agreement with Lanstead such that the Company's economic interest will be determined and payable in 18 monthly settlement tranches as detailed in the placement announcement of 20 November 2015. As consideration for entering into the sharing agreements, the Company issued 3,000,000 shares on 20 November 2015 and a further 5,000,000 shares on 11 March 2016 such that 83,000,000 shares, in total, have been issued to Lanstead pursuant to the Subscription Agreements at 31 March 2016. During the December 2017 quarter, the Company received \$23,750 in credit support instalments, net of sharing agreement settlements pursuant to the Subscription Agreements. The Sharing Agreements concluded on 13 November 2017 and accordingly, no amount remains invested in the now concluded Sharing Agreements at 31 December 2017.
